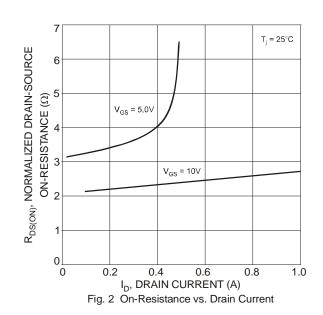

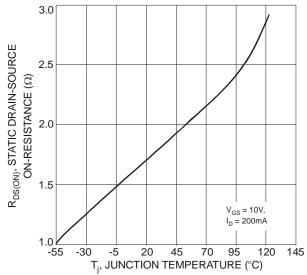
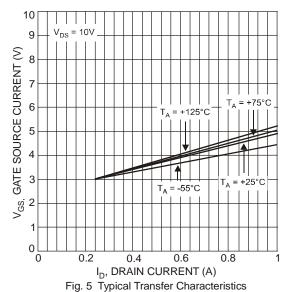


Fig. 3 On-Resistance vs. Junction Temperature

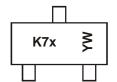

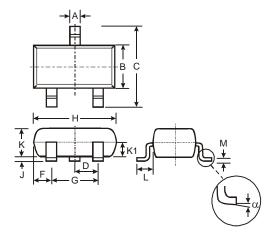

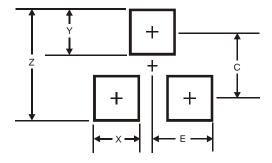
